

On motion of Mr. Isacks,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the expediency of establishing a post route from Monroe, in Tennessee, to Tompkinsville, in Kentucky.

On motion of Mr. Jenkins,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the expediency of establishing a post route from the town of Mamakating, in Sullivan county, by the Neversink Falls, to the town of Colchester, county of Delaware, in the state of New York.

On motion of Mr. Conway,

Resolved , That the Committee on Roads and Canals be instructed to inquire into the expediency of authorizing the President of the 7 0049 0050 United States to employ a skilful engineer to examine the raft on Red river, in the state of Louisiana, and territory of Arkansas, and report the most practicable means of removing the same, or opening a channel around it.

Mr. Livingston laid the following resolution on the table for consideration to-morrow:

Resolved , That the Secretary of the Treasury be directed to lay before this House, an account of the unclaimed dividends on the public stock, (if any) since the establishment of the present government.

On motion of Mr. Alexander, of Tennessee,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the expediency of establishing a post road from Hardinville, Hardin county, by way of McNairy court house, Hardiman court house, to Tipton court house; also, from Pari, Henry county, to Huntingdon, Carroll county; also, from Jackson, Madison county, by way of Harrisburg, to Dyer court house; also, from Pulaski, Giles county, by way of Lawrenceburgh to Waynesborough, Wayne county; also, from Reynoldsburgh to Paris, Henry county, all in Tennessee.

On motion of Mr. Woods,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the expediency of establishing a post route from the town of Pike, Allegany county, through the town of Eagle, to the town of China, in the county of Genessee, and state of New York.

On motion of Mr. Thompson, of Georgia,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the propriety of discharging Henry Freeman, postmaster at Carnesville, Franklin county, in the state of Georgia, from the payment of a sum of money due to the General Post Office, which sum was (as is alleged by the affidavits of the said Henry Freeman and Ormand Morgan) stolen from the post office at Carnesville, on the night of the 3d March, 1824.

On motion of Mr. Owen,

Resolved , That the Committee on the Public Lands be instructed to inquire into the expediency of establishing a board of commissioners for the purpose of adjusting the land claims in that part of Florida which lies in the state of Alabama.

On motion of Mr. Taylor,

Resolved , That the Committee on the Post Office and Post Roads be instructed to inquire into the expediency of establishing a post route from Schenectady to Ballston by Alexander's bridge
