Christopher was married to Sary Cagle , November 08, 1827 (Sarah "Sary" Cagle) in Franklin Co Georgia. Christopher was a widower who already had many children and was 40 years older than Sary. (There are a lot of information on Christopher in The Cagle in the South to 1850 Vol II pages 130 to 145 , can't write them all down but will try to get some of the info in.

By the 1830 Census , Leonard Cagle, c1780s - 1850s, who had various records in Franklin co. during the 1820s, had moved westward to Henry Co., Ga. where he was enumerated in the 50-60 age bracket . a full history of the Leonard Cagle family will appear in a chapter on Henry County, , later in the present series Leonard's daughter Sarah, however, remained in Franklin county, and was enumerated in the 1830 Census as the wife of Christopher Denman,

1830 Census of 1830, Franklin County,
Dinmon, Christopher 001001001-3001 (p. 214)

This census listing shows that Christopher Denman was in the 60-70 age bracket, and that his wife Sarah was in the 20-30 bracket, with three young daughters under the age of 5. the two males in the 10-15 brackets are not identified, but may have been Christopher's sons from his first marriage. Christopher died in 1834, and his wife Sarah headed the household until the minor children reached adulthood.

notes:

The Demons began to disappear form the franklin co. tax lists during the 1830s, beginnign with Richard in 1832 (last list on which he appears) Wm S. in 1834, Moses H. in 1835, and Felix G. in 1836. All four men, who were sons of christopher Denman and his first wife, joined the westward tide of migration, and it is known that by the time of the 1840 federal Census, Moses H. resided in cobb co., Ga and Felix G. in Carroll County, Ga. Christopher Denman died in Franklin Co. in 1834, after which his second wife , Sarah Cagle Denman, appeared as the owner of his estate on the Franklin Co. Tax lists in late 1830s. (page 138)

Federal Census of 1840, Franklin County,
Christopher Denman last appers on the tax listed as the head of his estate. sarah remined in frankline County,, and at the time of the 1840 Census was enumerated as follows:

1840 Census, Franklin co. Ga.
Denman, Sarah 21-101101 (Widow of Christopher)

in this listing Sarah was enumerated in the 30-40 age bracket (born 1800-10 era) and she had three young males and three females in her houshold. all of these children cannot be idetified by the editor, but it is know that three of them were bornto her and her late husband, Christopher Denman. These three, as known from Christopher's 1834 Will, and from census records and family records, were Susannah Denman, born c1830, James Leonard Denman, 1832-1836, and Margarite Denman. the editor has been unable to lacated this family group for the 1850 census , but Sarah Denman and son James Leonard Denman were still in franklin co. at the time of the 1860 census.

Will of Christopher Denman

Franklin County, Georgia
May 1, 1834

Know all men by these presents, that I Chrisophr Denman of the State aforesaid and County of Franklin, for and in consideration of the natural love and affection which I ahve and bear towards my wife Sally Denman, and my three children to wit: Susannah Denman, Leonard Denman, & Margaret Denman, and for and towards the better support and maintenance of my said wife and three young children before named after my surcease, and for diverse good causes me hereunto moving, have given , granted and sold, and by these presents do freely give, grant and sell unto my said wife Sally Denman during here natural live, and after her decease, to my said three children before named, all tract or parcel of land wheron I now live, containing three hundred acres more or less, granted to _____ & bounded by and joining lands of James Stone, elias Burgess & Sturdy Garner on Gum Log Creek together with all my house hold & kitchen furniture which I may be possessed of at my decease and which is to remain in support and maintenance of my said wife and children before named and after her decease to be equally divided among my said three children, to have and to hold the said tract or parcel of land & whatever property and before which I may be possessed of at my decease, unto the said Sally Denman during her natural life, and after her decease to go to & become the property of my said three children as before named, having hertofore given all my older children previous to my intermarriage with my beloved wife Sally Denman, all my valuable property provided never the less that I am to use and enjoy the same during the few days of my natural life. In witness whereof I ahve her unto set my had and seal the 1st day of May in the year of the Lord, one thousand eight jundred and thirty four
